

## Chinese New Year 2023 Campaign (“Promotion”)

### Terms and Conditions

Customers must <b>place a vehicle booking</b> for a Certified Vehicle within the above stipulated promotion period; and</li><li>2. <b>Obtain loan financing</b> in relation to their Certified Vehicle from any financial institution registered and licensed by Bank Negara Malaysia (“Loan Financing”).</li></ol>
Promotion Qualifications	<p>Eligible Customers shall be entitled to receive the following benefits (“Promotional Benefits”):</p> <ol style="list-style-type: none"><li>1. For each selected Certified Vehicle purchased by the Eligible Customer, they shall be entitled to:<ol style="list-style-type: none"><li>a. A subsidized interest rate of only 1.88% for the first eight (8) months of their Loan Financing (Subsidized Interest Rate”);</li><li>b. The Subsidized Interest Rate shall be given to the Eligible Customers in the form of an upfront rebate that shall be deducted directly from the purchase price of the Certified Vehicle;</li><li>c. The specific amount of the Subsidized Interest Rate shall be calculated by the Organizer based off the existing interest rate of the Eligible Customers’ Loan Financing;</li><li>d. The Subsidized Interest Rate shall only be valid and applicable towards the first eight (8) months of the Loan Financing tenure and period only, after the eight month, the Subsidized Interest Rate shall no longer be valid and applicable and the Eligible Customers’ interest rate shall revert to the original rate as determined by their Loan Financing; and</li><li>e. For the sake of clarity, excluding the Subsidized Interest Rate, no additional payment, reimbursement, remittance or deposit shall be given to the Eligible Customers.</li></ol></li></ol>
